- 5 years

LL.M in International Law

- 1 year

One year LLM Course on the topic of International Law was approved by the University for commencing the classes. An agreement was signed with Kent Chicago University by Ms. Anita Kurg, who is the Dean. It was decided that after one Semester in India, the students opting Kent School of Law can pursue their course at USA and get a degree of Kent Chicago. Students pursuing course at Kent need to have their eligibility for language test and need to meet their costs of tuition and living costs at Chicago Kent. The process will be facilitated by Hindustan School of Law with a proper recommendation of payment on completion of prescribed formalities in India. Those who want to complete two Semesters in



India will get Hindustan University Degree for LLM, For getting dual LLM Degree from Kent and Hindustan, student need to complete one more Semester after coming from Kent after the completion of the First Semester.
